
ALLOCATION OF QUOTA FOR EXPORT OF SUGAR

WHEREAS, the Economic Coordination Committee (ECC) of the Cabinet, in case No.ECC-12/02/2023 dated 11.01.2023 decided to allow export of 250, 000 MT of SUGAR with the following percentage;

2. **AND WHEREAS** the ECC in Case No.ECC-33/05/2023 dated 26.01.2023 decided that provincial Cane Commissioner shall allocate quota for export of sugar within seven days (7) of the date of issuance of notification by Ministry of Commerce as per policy already approved by the ECC.
3. **AND WHEREAS** all the Sugar Mills of Khyber Pakhtunkhwa approached cane Commissioner Khyber Pakhtunkhwa Office for allocation of their quota already agreed by the Sugar Mills.
4. **NOW THEREFORE**, in pursuance of the office Memorandum No.F.No.7 (2)2012-Exp-III dated 28.01.2023 issued by Ministry of Commerce, Government of Pakistan. I, **Mohammad Yasir Hassan** Cane Commissioner Khyber Pakhtunkhwa, do hereby allocate quota for export of sugar on the basis of data of sugar produced provided as under:-


