ORDER

ALLOCATION OF QUOTA FOR EXPORT OF SUGAR

No. C.C (Admin)1-97/10 (Pt-III) 53: WHEREAS, the Economic Coordination Committee (ECC) of the Cabinet, in case No. ECC-12/02/2023 dated 11.01.2023, decided to allow export of 250,000 MT of sugar with the following percentage:

i.	Punjab	61%
ii.	Sindh	32%
iii.	KPK	07%

- 2. AND WHEREAS, the ECC in Case No. ECC-33/05/2023 dated 26.01.2023 decided that Provincial Cane Commissioners shall allocate quota for export of sugar within seven days (07) of the date of issuance of Notification by Ministry of Commerce as per policy already approved by the ECC.
- 3. AND WHEREAS, data regarding sugarcane crushed and sugar produced during the crushing season 2021-22 was obtained from the Punjab Sugar Mills Association (Punjab Zone). Analysis of data was done. It was observed that in certain areas of the province, sucrose content / recovery of sugar was higher than the other areas and allocation of quota on the basis of sugar produced would deal a double whammy to the sugar mills having less sucrose content / recovery of sugar. It was, therefore, deemed judicious and equitable to allocate quota on the basis of sugarcane crushed by each sugar mill.
- 4. **NOW THEREFORE,** in pursuance of Office Memorandum No. F.No.7(2)/2012-Exp-III dated 28.01.2023 issued by Ministry of Commerce, Government of Pakistan, I, **MUHAMMAD ZAMAN WATTOO**, Cane Commissioner Punjab, do hereby allocate quota for export of sugar on the basis of data of cane crushed provided by the Punjab Sugar Mills Association (Punjab Zone), as under:
